Hood Theological Seminary's mission is "to prepare women and men for bold and creative leadership for the Christian church in a diverse world." An essential component of this mission is an educationally effective curriculum that prepares graduates to do the important work described above. Below are two indicators of our curriculum's educational effectiveness: (1) data from an online exit survey taken by the HTS class of 2019 (indirect measure) and (2) assessment data compiled by faculty based on student performance on selected course tasks, which function as direct measures of the extent to which students have met curricular goals.

## II. Assessment data compiled by faculty based on student performance (Direct Measure)

### A. Biblical Studies

Students demonstrate knowledge of biblical content, background, methods, and issues and ability to analyze the biblical text in its historical, literary and cultural contexts with particular attention to the issues of the marginalized, oppressed and emotionally hurting and to evaluate critically different viewpoints and perspectives on the biblical texts, assessing the relevance for their present context. Success is achieved when 80% of the students in the introductory courses score at least 80% on exams and on papers/essays.

2018-19 Results: 74% scored at least 80% (B-) or better.

Students demonstrate, in the context of an exegesis paper, the ability to analyze the biblical text in its historical, literary and cultural contexts; to evaluate critically different viewpoints and perspectives on the biblical texts; and to assess its relevance for their present contexts. Success is when 80% graduates have fulfilled the exegesis requirement by earning a B- or better on an Exegesis paper at some point in their Hood career.

**2018-19 Results:** 91% of the graduates scored at least 80% (B-) or better on an Exegesis Paper.

#### **B. History of Christianity**

HTS students demonstrate the capacity to practice ministry in ways that provide bold and creative leadership for the Christian church in a diverse world in the following ways:

• Completing a reflection paper in "CHT 115 *History of Christianity in a Global Context*" that assesses the student's grasp of the complexity and cultural nuances of two millennia of Christianity. Success is when 70% write well-crafted 1-2 page reflection papers with a grade of "B" that indicate a grasp of the cultural identity and ethos of the congregation observed and understanding of the general socio-historical Christian context from which it emerged.

2018-19 Results: 8 of 9 students (88.89%) scored a grade of "B" or above.

• Completing an in-class examinations in "CHT 200 *History of Christianity in the United States*" that will assess students' knowledge of the role that institutional religious bodies and religious ideologies have played in both the oppression and liberation of marginalized groups in American culture. Success is when 70% of the class achieve at least an 80% on the CHT 200 final examination.

**2018-19 Results:** 6 of 9 students (66.67%) scored above 80%.

HTS students demonstrate their ability to apply the wisdom and insights of the biblical texts, theological traditions, and history of the Church to the diverse cultural contexts in which they will minister in the following ways:

 Completing in-class examinations in "CHT 115 History of Christianity in a Global Context" and "CHT 200 History of Christianity in the United States" that will assess students' knowledge of the history of the Christian faith. Success is when 70% of the class achieve at least 75% on the CHT 115 final examination and when 70% of the class achieve at least 80% on the CHT 200 final examination.

**2018-19 Results for CHT 115:** 6 of 9 students (66.67%) scored above 75%. **2018-19 Results for CHT 200:** 6 of 9 students (66.67%) scored above 80%.

• Writing a critical research paper in CHT 200 that will measure students' ability to engage in historical analysis and interpretation.

**2018-19 Results:** 9 of 9 students (100%) scored a grade of "B" or above.

#### C. Theology and Ethics

Students demonstrate their ability to apply the wisdom and insights of Christian theological traditions to the diverse cultural contexts in which they will minister by writing a paper in which they analyze a designated challenge or issue in the life of the contemporary church and offer a constructive response to it by way of a historic church doctrine, a particular Christian theological tradition, or the work of a pivotal contemporary Christian theologian. Success = 80% of the class evaluated as either "excellent" or "adequate."

**2018-19 Results ("Analyze"):** 12 of 23 students scored in the "excellent" range (52.17%) and 11 of 23 students scored in the "adequate range" (47.83%). Totals: 23 of 23 (100%).

**2018-19 Results ("Apply"):** 7 of 23 students scored in the "excellent" range (30.43%) and 11 of 23 students scored in the "adequate range" (47.83%). Totals: 18 of 23 (78.26%).

Students demonstrate the capacity to practice ministry in ways that contribute to the holistic transformation of society by constructing a theologically reflective strategic plan of communal action in response to a contestable issue or public controversy. Success = 80% of the class evaluated as either "excellent" or "adequate."

**2018-19 Results:** 16 of 21 students scored in the "excellent" range (76.19%) and 4 of 21 students scored in the "adequate" range (19.04%). Totals: 20 of 21 (95.23%).

#### **D.** Pastoral Theology

**2018-19 Summary Assessments:** Spiritual Maturity, Inclusive Language, Pastoral Care, and Self-Awareness

- 100% of the students were able to demonstrate spiritual maturity as discerned by field mentors and self-perception.
- Students used inclusive language 66% of the time during worship leadership and preaching in chapel and in classes where preaching and worship leadership was assessed.
- 100% of the students were able to communicate in excellent manners about their experiences with the poor, the sick, and the marginalized and how they attempted to communicate and apply the resources of the caring Christ to these people. The students' descriptions were in the form of verbal responses to the professor and in writing in the form of their reflection papers.
- 100% of the students were able to write superb "care plans" for a variety of situations, like addiction, incarceration, homelessness, abusiveness. The students' writings were in the forms of verbatims and ministry reflection reports.
- Students who were assigned texts that pertained to persons hurting emotionally or physically demonstrated competence in connecting the messages of those texts in ways that ministered effectively to the pain and distress of the congregants 66% of the time.
- 100% of the students were able to describe an adequate amount of self-awareness in how their ministerial experiences are impacting the various components of their lives such as spiritual, physical, mental, etc. The students displayed their awareness through peer group reflection and conversations with the professor.

**Preaching:** Success defined as at least 50% of students scoring in "excellent" category and 90% in the "acceptable" category in a sermon prepared and delivered in PTH 103:Worship and Preaching I.

• Answering the question, "What in the world is God doing about our world?"
